#### **QUALIFICATIONS:**

Equivalent to the completion of the twelfth grade; ability to lift, carry and push tools, equipment, and supplies weighing 50 pounds or more; and occasionally lift and/or move up to 100 pounds; and work in tight and confined spaces including precarious places, on elevated platforms and aerial devices; and be able to work in inclement weather conditions.

### ADDITIONAL REQUIREMENT:

A valid Class C California driver's license with the ability to obtain a valid Class B California driver's license (with tanker endorsement) within six months of employment.

<u>Note</u>: Work Schedule - "4/10" (Monday – Thursday, 6:30 a.m. to 5:00 p.m.). Performs after-hours emergency work on an "as needed" basis and on-call duties on a rotating basis. Must be able to respond to on-call responsibilities at the Municipal Service Center within 30 minutes. <u>Special Requirement</u>: In accordance with Cal/OSHA regulations, in order to get an airtight face seal while working with a respirator, employees in this position may be required to be clean-shaven (no beards, long mustaches, long sideburns or lengthy head hair). Ability to pass Department of Transportation (DOT) pre-employment drug screen and DOT medical requirements.
