- Prepare biennial payroll budget and perform mid-year payroll budget analysis
- Coordinate changes in employee benefits, deductions and salaries to provide accurate payroll and accounting records
- Compile annual State Controller's Compensation Report
- Perform professional accounting duties in the preparation and maintenance of the City's financial records
- Assist in the preparation of financial statements, notes and statistics for the Comprehensive Annual Financial Report
